- 2 A Conveyance affecting the land in this title and other land dated 10 November 1876 made between (1) Matilda Orred and others and (2) Elizabeth Kelly and others contains the following covenants:-

And each of them the said parties hereto of the second part doth hereby for himself and herself his and her heirs executors administrators and assigns covenant with the said parties hereto of the first part their heirs and assigns that they the said covenanting parties respectively shall not erect any shops or houses on the said land or any part thereof of less annual value than Eighteen Pounds each nor carry permit to be carried on upon the said land or any part thereof any trade or business which may be considered a nuisance to the neighbourhood.

- 3 (01.06.2010) The land is subject to the lease set out in the schedule of leases hereto.
